What does all this mean?

Here are a few common questions and answers which will help to define the role of the Desrochers Home Owners' Association (DHOA) and it's Board of Directors (BoD).

What is the Desrochers Home Owners' Association?

The DHOA is a non-profit association governed by the Alberta Societies Act. It was created by (Desrochers developer MLC Group,) to ensure that certain features and amenities in our community are maintained and managed for the long-term use and enjoyment of its member residents.

The DHOA helps ensure financial sustainability over time and the maintenance of the community's enhanced landscaped features.

Do all home owners have to pay the annual fee?

Yes.

Membership in the DHOA is automatic and mandatory with the purchase of all properties and is secured by an encumberance registered on your land title.

What is the amount of the DHOA Annual Fee and when is it due?

The annual fee for the 2025-2026 fiscal year is \$166.67 plus \$8.33 GST, totaling \$175.00.

Multi-family homes are billed on a per acre basis.

Fees will be reviewed annually by the DHOA BoD and are subject to change.

Your annual fee will be due April 1, 2025.

Unpaid fees will be subject to interest and any legal or collection costs.

The DHOA fiscal year will run from April 1st until March 31st of the following year with fee reminders sent by the DHOA annually.

What benefits do you receive by paying the annual DHOA fee?

Residents enjoy the benefits of enhanced maintenance of selected amenities and assets within Desrochers. These enhancements encompass a variety of features including, but not limited to: the beautification of Desrochers entry signage with seasonal flowers and/or additional landscaping, maintenance of the entry boulevards, electricity costs for entry signage, fountain installation, maintenance and seasonal storage, landscaping of the pond surrounds, upkeep of the pond view point landings and features, seasonal festive lighting, and for the updating and maintenance of the DHOA community website: desrochershoa.com

These efforts ensure that Desrochers Villages can continue maintaining open spaces and shared assets to a satisfactory standard fostering a vibrant and well-cared-for community.

How is the DHOA governed?

The DHOA operates under the Alberta Societies Act and the DHOA established bylaws. Governance is overseen by a volunteer Board of Directors which was elected at the inaugural Desrochers Home Owners' Association first Annual General Meeting held on September 17th, 2024. The Board of Directors is composed of seven resident members elected to represent our community.

Fees are determined annually by the Board of Directors after a full review of an annual operating budget. A summary of the 2025 operating budget can be found on the DHOA website: desrochershoa.com.

Desrochers' developer, (MLC Group,) has been actively facilitating the seamless transition of the DHOA management following the first AGM. Over the past several months, MLC Group has implemented a robust exit strategy, including BoD development training and the establishment of efficient administrative and accounting systems. These efforts are designed to ensure the DHOA can fully manage its responsibilities moving forward.

Doesn't the Municipality maintain all common spaces?
